## 2. Minutes of last meeting/Matters arising

## 4.1. Correspondence

## 4.1.1 SCVO Grant

JC confirmed that she had received an email from the SCVO stating that we had been successful in our grant application. We had not received the full amount requested but had been given a grant for £500. Funding will be released as soon as we provide our bank details.

A discussion took place about the issues that had been encountered while trying to set up the bank account which has resulted in us still not having an account.

**Action:** DP to visit the bank tomorrow and report back by email to the Chair and Secretary. If nothing is forthcoming it is recommended that we look at opening an account with another bank.

4.2. Leaflets SA / JT

#### 4.2.1 Content

For those persons not previously present a brief background of the leaflets took place. Discussion took place around a A5 double sided leaflet that would promote the Friends Group and highlight their link to the Wildlife Trust.

SA proposed that the Wildlife Trust could help out with the layout etc. JW asked if we would be able to have a template so that they could be used at the Titford Boat Rally.

**Action:** SA to co-ordinate with JT who had previously agreed to undertake this role.

4.2.2 Distribution AW / RS

JC produced a list of road names with approximate numbers of residential homes in them and the Big Local map for planning how / when we were going to distribute the leaflets. We still need to look at Businesses in the area.

**Action:** AW agreed to look at the rounds / numbers for distribution. RS said that he could help with the distribution on his estate.

## 4.3 New Membership
